Slip Sale Procedure

Slip Buyer must submit completed “Application to Purchase” along with processing fee of \$100.00 (payable to Jupiter Yacht Club Marina Assoc.)

Insurance must be obtained for the Vessel with 1 million Dollars in liability insurance. In addition, JYC Marina must be listed as additional insured on the policy.

Jupiter Yacht Club Marina must receive completed “Application to Purchase”, copy of the “Sales Contract” and color photo of the vessel prior to processing “Estoppel” and “Certificate of Approval” for Title Company.
